The Shifting Sands of Bringing Pediatric Palliative Care across Care Settings

Course objectives

- Identify challenges in pediatric palliative care across care settings.
- Describe interdisciplinary and inter-organizational approaches to concurrent care and telemedicine.
- Illustrate the value of collaborative palliative care in improving outcomes for patients and their families.
- Recognize ethical dilemmas and professional responsibility in pediatric palliative care across various care settings.

This one-day Midwinter seminar designed in case study format is relevant for providers in all disciplines. Presentations will focus on clinical and home-based challenges care providers face when using concurrent care and telemedicine to coordinate and manage complex medical care needs - what worked or did not, and what was learned from each particularly challenging case. An expert panel will provide reflection following both morning and afternoon case presentations, and participants also will be actively involved in follow-up discussions. The conference seeks to provide participants with opportunities to pose questions, engage in discussion, and network with pediatric palliative care experts and providers throughout the country. Morning Plenary:

Benefits and Challenges of Pediatric Concurrent Care - Evidence from 10 years

Lisa Lindley, PhD, RN, FPCN, FAAN is an Associate Professor and Nightingale Endowed Faculty Fellow in the College of Nursing at the University of Tennessee, Knoxville. She received her doctoral degree in nursing from the University of North Carolina at Chapel Hill and master's degree in business from the University of Wisconsin, Madison.

Dr. Lindley is a child health services and policy researcher. Her research focuses on health care systems and policy interventions that promote quality, accessible care for children and their families at end of life. Dr. Lindley has expertise in advanced statistical techniques, data management, and claims-based data. She is the recipient of a NIH pre-doctoral fellowship (T32), AHRQ dissertation award (R36), NIH career development award (K01), and NIH research project grant (R01) in support of her research work.



Afternoon Plenary: The Future is NOW: Pediatric Tele-Hospice and Palliative Care

Jason Reynolds, MD, Associate Medical Director, Palliative Care Program at Cook Children's Medical Center, has a passion for helping children and their families navigate the medical system when they are faced with complex medical conditions. As part of this passion, Dr. Reynolds leads a program that provides virtual home-based care for children and their families who prefer to have as much of their care as possible in the comfort of their own home. This care may be especially valuable when home is far from the larger medical center.

Dr. Reynolds is a board certified pediatrician with sub-specialty training in pediatric hospice and palliative medicine. He earned his medical degree at the University of Texas Southwestern Medical Center in Dallas. He completed his residency at the University of Colorado, Denver. He completed his fellowship training at St. Jude Children's Research Hospital / Le Bonheur Children's Hospital combined program through the University of Tennessee Health Science Center.
